#### 2022/35 COMMITTEE MEETING MINUTES

#### 2022/27 FINANCIAL MATTERS

- (a) Consideration of the budget Committee noted the revised budget figures supplied by Grants Officer which considered the confirmed tax base. After discussion the following suggestions was considered:
  - Total precept figure be adjusted to £775,000, this is an 8.94% increase on last year's precept. This produces a £14.19p annual increase in Band D.

- Increase Chard Town Council Run Events, both expenditure and income to £5,000. This was previously reduced to £1,500 at the first budget planning meeting from a suggested £8,000 based on 2022/23 events
- The remainder of monies to be set aside as a reserve for possible increase in energy bills (c.£14,000).

**RESOLVED** to agree the suggested adjustments as outlined above for consideration at the next Full Council 24<sup>th</sup> January
