Public Participation Time

There were 20 members of the public present. The following matters were raised:

- Concern regarding disruption to local businesses due to the ongoing HSHAZ
 programme of street scene improvements. Chard Town Council, South
 Somerset District and Somerset County Councils had been sent letters on this
 subject where full details of the concerns and requests were outlined. A written
 response to the issues raised would be provided;
- The following comments were shared on planning application 22/0023/FUL
 - The map showed the site line going through the adjacent property:
 - There would be a significant loss of green space and increase to hard surfacing;
 - There was allocation of 25 car parking spaces but only 2 electrical charging points;
 - The drainage report lacked detail.

COMMENT: The following concerns were raised:

 Concerns were expressed that the proposed access and egress to the site onto a busy main road could be considered detrimental to highway

safety:

 The proposal had not provided adequate car parking bearing in mind the limited public transport infrastructure in place; There was concerns that there would be significant 'Run off' from the proposed hard standing area that was known to be a saturated area when wet.

It was recommended that the application be accepted subject to the following recommendations being taken into account:

- That the Highways Officer review the practicalities and safety of the proposed entrance taking into consideration the concerns expressed above;
- That provision of more data on how the 'Run off' capacity from the increased hard surfacing had been calculated and assess whether the submitted mitigation proposals were adequate given the recent issues of flooding experienced in Chard.
